



Town of Manchester Landfill and Transfer Station Public Usage Program: Pay-As-You-Dump Cash Option



This program is designed to give the public (individuals and businesses) the option of disposing of acceptable materials (*hazardous, asbestos, radioactive, waste etc. are all prohibited*) at the Town of Manchester Landfill and/or Transfer Station without having to acquire a commercial vehicle permit to use the facility.

With the Pay-As-You-Dump (“**PAYD**”) Option, the customer will drive onto the truck scale and inform the scale operator they desire to dispose of acceptable materials using the **PAYD** option at the Landfill. There is a waste disposal form that needs to be completed. It will identify 1) where the materials are coming from, 2) the person/company delivering the materials and 3) a description of the materials for disposal. **A cash deposit of \$100.00 (\$200.00 for box trucks) and a valid driver's must be left with the scale operator. If using a rental vehicle, a copy of the rental agreement will need to be reviewed.** After the load has been recorded in the computer, the customer will be directed to the Landfill and/or Transfer Station to unload. Sortation of applicable materials may be required, depending on what materials are being delivered for disposal. When empty, the customer will return to the truck scale to weigh out, at which time the net weight and cost of the materials disposed of will be calculated. **Cash, debit and credit cards are accepted for payment.**

The Pay-As-You-Dump Cash Option is based on the rate of \$200 per ton (2,000 lbs.) with a minimum disposal fee of \$50.00 for loads weighing 500 pounds or less. If the weight is above the 400 pound minimum, then the load will be charged based on the actual weight of the materials. For example, a 640 Lbs. load of materials would cost \$64.00 for disposal.

Acceptable materials are Household Bulky Waste (personal belongings, furniture, appliances, etc.), Recyclables (cardboard, metal, leaves, grass, rigid plastics, textiles) Electronics, Construction Debris (lumber, drywall, shingles, etc.), and Yard Waste.

Any Municipal Solid Waste (i.e., kitchen garbage) and/or Recyclables must be sorted and disposed of in the proper areas of the Transfer Station. Certain items, such as Freon Appliances, Electronics, Tires, Mattresses/Box-springs etc. will incur per item charges, on top of the weight based disposal fee. Please see the attached list for current per- item pricing.

Finally, if you require frequent use of the facility, it is likely more economical to purchase a commercial vehicle permit and establish a regular customer account with the Town.
