SUMMARY OF RECOMMENDATIONS

- The Manager/Council form of government is retained.
- Changes the title of the "General Manager" to "Town Manager."
- Maintains the current name of the Board of Directors in the Charter, rejecting a proposal to change the name to "Town Council."
- Continues the use of at-large voting for all municipal elections.
- Maintains current terms of office for the Board of Directors and Board of Education.
- Provides for the direct election of Mayor. The Mayor will remain a member of the Board of Directors and electors will also select the remaining 8 members of the Board of Directors, however, the losing mayoral candidates shall have the votes they received for Mayor included in the compilation and the determination of Board of Directors membership. Minority representation requirements will still apply.
- Provides that in the event of the death or resignation of the Mayor of the Board of Directors, the Deputy Mayor shall become Mayor.
- Increases the compensation for the Board of Directors: Mayor \$7,500; Deputy Mayor, Secretary and Minority Leader - \$6,000; members of the Board of Directors - \$5,000 and such compensation shall be adjusted biennially, by the most recent Consumer Price Index. This would represent the first increase in compensation since 1996.
- Amends the Charter to provide that minority party vacancies on the Board of Directors and on appointed boards and commissions require that the nomination be made by member of the Board of Directors with the same political party affiliation as the vacating member.
- Eliminates the requirement for an annual Joint Board of Directors/Board of Education meeting.
- Clarifies the authority of the Board of Directors to establish Departments, Offices, Divisions and positions by ordinance or resolution.
- Provides the Board of Directors with the authority to establish by ordinance additional standards of official conduct but maintains the current standards in the Town Charter.
- Eliminates residency requirements for the Superintendent of Schools, Chief of Police, Fire Chief, Director of Public Works, and the Superintendent of Water and Sewer Department.
- Increases the dollar thresholds for settlement of claims by the Town Attorney, the General Manager, and the Board of Directors.
- Increases the number of Justices of the Peace to 45.
- Recommends that the Town Clerk remain an elected position.
- Specifies that the Board of Directors establish the Town Clerk's salary for the coming term not later than July 1st of the year of a Town Clerk election.
- Conforms the Charter with the provisions the Town Code of Ordinances to specify four-year terms for the Town Clerk and Registrar of Voters.
- Makes numerous technical and administrative revisions to various sections of the Town Charter, including: adopting the use of gender-neutral pronouns and official titles throughout the Charter; amending the terminology in the Human Services section of the Charter; and, adding clarity to the budget timetable in the Charter.
- Removes the following Boards and Commissions that are advisory in nature from the Town Charter and permits the Board of Directors to establish those bodies by resolution or

ordinance instead: 1) Library Board; 2) Advisory Recreation and Park Commission; and 3) the Advisory Board of Health.

- Increases the membership of the Planning and Zoning Commission to 9 members.
- Requires appointing authorities for any Board or Commission to consider the interests of gender identity and racial equity and make a good faith effort to seek out individuals for such appointment that reflect such equity.
- Recommends that the General Manager and town staff develop training for members of Boards and Commissions and create a handbook for newly appointed members of Boards and Commissions.
- Recommends that the Board of Directors consider the establishment of a Commission to study whether the official name of the "Town of Manchester" should be changed to the "City of Manchester."
- Rejected proposals to amend the Charter regarding the powers of the Board of Directors concerning: investigatory powers; the ability to directly question department heads and initiate reports outside of the General Manager; and, the ability to draft proposals absent the direction of the General Manager.
- Rejected a proposal to allow voters to vote for the total number of positions to be elected.

5	This Charter Revision Commission was established by the Town Board of Directors on April 6,
6	2021. Appointed to the Commission were: Josh Howroyd (Chair), Dr. Maria Cruz (Vice Chair), Dr.
7	Diane Clare-Kearney (Secretary), Jacqueline Crespan, Cheri Eckbreth, Jennifer Fiereck, Margaret
8	Hackett, Jerald Lentini, MD Masudur Rahman, Louis Spadaccini and Mark Tweedie. On November
9	16, 2021, two members, Jacqueline Crespan and Jennifer Fiereck, resigned and were replaced by
10	Kelly Lierzer and Zachary Reichelt. Mr. Reichelt resigned on March 1, 2022 and was replaced by
11	Steven Norton on April 5, 2022.
12	
13 14	The Resolution creating the Charter Revision Commission charged it with considering the following:
15	• Charge # 1. Review of substantive or administrative amendments to the Charter as
16	identified by the Town Administration's and Town Attorney's review of the Town Charter.
17	• Charge # 2. Review of Section 2-14 of the Town Charter, Justices of the Peace, to increase
18	the authorized number of Justices of the Peace to 30.
19	• Charge # 3. Review of Section 9-1 of the Town Charter, Election to Board of Education to
20	consider revision of the terms of office.
21	• Charge # 4. Review of Section 14-1 of the Town Charter, Recreation and Park Commission,
22	to consider increasing the membership of the commission from 7 members to 9 members.
23	• Charge # 5. Review of Sections 3-2 and 3-3 of the Town Charter, election of the Board of
24	Directors, to consider revision of the terms of office and compensation.
25	• Charge # 6. Review of Sections 3-2 and 9-1 of the Town Charter, election to the Board of
26	Directors and Board of Education, to consider the use of at-large elections.
27	• Charge # 7. Review of Sections 3-1 and 4-5 of the Town Charter, powers of the Board of
28	Directors, to consider the investigatory powers and ability to directly question department
29	heads and initiate reports outside of the General Manager, as well as investigate matters
30	within that department notwithstanding the General Manager's oversight of such
31	department.
32	• Charge # 8. Review of Section 3-1 of the Town Charter with respect to the formulation of
33	boards and commissions and the appropriateness of establishing those bodies by
34	resolution or ordinance instead, so as to have flexibility in amending their structure and
35	responsibilities absent charter revision.
36	Charge # 9. Review of Section 4-5 of the Town Charter, General Manager appointments as
37	opposed to Board of Directors appointments, not otherwise required by state or federal
38	law.
39	• Charge # 10. Review of Section 3-1 of the Town Charter, powers of the Board of Directors,
40	to provide the Board of Directors with the ability to draft proposals absent the direction of
41	the General Manager.
42	• Charge # 11. Review of Section 3-5 of the Town Charter, powers of the Board of Directors,
43	to clarify leadership including succession in the event of the resignation of the
44	Chairman/Mayor of the Board of Directors.

 Charge # 12. Review of Section 3-1 of the Town Charter, to review training opportunities and possible requirements for members of boards and commissions. Charge # 13. Review of Chapter III and Chapter IV of the Town Charter, to consider the structure of the council-manager form of government.
The review by the Charter Revision Commission was not restricted to the 13 areas identified above. Deliberations on the 13 specific charges from the Board of Directors and over a dozen other items were considered over the course of 20 meetings and 5 public hearings held on July 12, 2021, August 5, 2021, September 9, 2021, January 5, 2022, and May 4, 2022. This work resulted in a series of recommendations by the Charter Revision Commission that was submitted to the Board of Directors as a Draft Report on May 18, 2022.
Recommendations
Charge # 1. Review of substantive or administrative amendments to the Charter as identified by the Town Administration's and Town Attorney's review of the Town Charter.
1A. Gender Neutral Pronouns and Use of Official Titles
Recommendation: The Charter Revision Commission voted 11-0 on January 31, 2022, to <u>adopt</u> the use of gender-neutral pronouns and official titles throughout the charter. (<i>See draft language, Appendix pp. 1 - 18</i>)
Discussion/Rationale: This recommendation changes multiple references in the masculine gender, such as he, him or his, to in most cases, a specific reference to an official title that would apply to each specific instance.
1B. Amending Terminology in Chapter XIII, Department of Human Services (Sections 13-1 & 13-2)
Recommendation: The Charter Revision Commission voted 11-0 on February 23, 2022, to amend terminology in Chapter XIII of the Town Charter, Department of Human Services. (<i>See draft language, Appendix pp. 19 - 20</i>)
Discussion/Rationale: In coordination with Director Joel Cox and Assistant Town Attorney John Sullivan, the Human Services Chapter of the Charter has been rewritten to reflect the current mission and services of the Department of Human Services and to remove inappropriate and obsolete language from the Charter. One example is that we change references to "mentally ill persons, mentally retarded persons, inebriates, epileptics, indigents and incompetents" to "persons with mental health disabilities, persons with developmental disabilities, persons with disabilities, persons with disabilities, persons with developmental disabilities, persons with disabilities, persons with disabilities, persons with developmental disabilities, persons with disabilities, persons with disabilities, persons with developmental disabilities, persons with disabilities,

- 1 1C. Budget Timetable – Clarify Dates 2 3 **Recommendation:** The Charter Revision Commission voted 11-0 on February 23, 2022, to amend various budget provisions in the Town Charter to specify dates rather than the number of 4 5 days before the beginning of the fiscal year. (See draft language, Appendix pp. 21 - 22) 6 7 **Discussion/Rationale:** The Commission recommends changing various references from 110, 8 105, 100, 75 or 45 days prior to the beginning of the fiscal year to specific dates: March 13th, March 18th, March 23rd and April 17 and May 17th, respectively. The Commission believes this provides 9 clarity for these sections of the Charter. Also recommended is an amendment regarding the 10 budget adoption process, clarifying that the Board of Directors shall convene to vote on a final 11 12 budget not later than April 17th of each year, however, it provides flexibility for final action by the Board of Directors on or before May 17th of each year. 13 14 15 1D. Eliminate Requirement for Joint Board of Directors/Board of Education Meeting 16 **Recommendation:** The Charter Revision Commission voted 11-0 on February 23, 2022, to 17 eliminate the requirement for a Joint annual meeting between the Board of Directors and the Board 18 19 of Education. (See draft language, Appendix p. 23) 20 Discussion/Rationale: Originally, this provision was added in 2003 to have the two Boards meet 21 22 annually to discuss possible consolidation of services. The Commission believes that a Charter 23 mandate of an annual meeting is no longer necessary. It is worth noting that there is no prohibition 24 of such meetings taking place between the two Boards at any time and on any issue. 25 26 **1E. Settlement of Legal Claims** 27 28 **Recommendation:** The Charter Revision Commission voted 10-0 on March 21, 2022, to 29 recommend that Section 18-1 of the Town Charter be amended to increase the dollar thresholds 30 for settlement of claims by the Town Attorney, the General Manager, and the Board of Directors. 31 (See draft language, Appendix p. 24) 32 Discussion/Rationale: This change would: allow the Town Attorney to settle claims not to 33 exceed \$10,000, unilaterally (currently \$7,500); allow the Town Attorney to settle claims in 34 excess of \$10,000 but not exceeding \$20,000, with the approval of the Town Attorney and the 35 General Manager (currently \$7,500 and \$15,000, respectively); and require that claims in excess 36 of \$20,000 be approved by the Board of Directors (currently \$15,000). These dollar thresholds 37 38 are updated periodically, most recently in 2008. 39 40 1F. Terminology Changes to Reflect Current Names of Offices and Positions 41 42 **Recommendation:** The Charter Revision Commission voted 11-0 on April 18, 2022, to
- 43 recommend that Section 3-1 of the Town Charter be amended to clarify the authority of the Board

2 (See draft language, Appendix pp. 25-26) 3 4 **Discussion/Rationale:** This change clarified current practice and is consistent with Section 2-2 5 of the Town Charter. 6 7 Charge # 2. Review of Section 2-14 of the Town Charter, Justices of the Peace, to increase 8 the authorized number of Justices of the Peace to 30. 9 10 Recommendation: The Charter Revision Commission voted 6-5 on January 31, 2022, to increase the number of Justices of the Peace to 45. (See draft language, Appendix p. 27) 11 12 Discussion/Rationale: An informal survey of the number of Justices of the Peace in other 13 14 Connecticut municipalities showed Manchester on the low end with 15 Justices of the Peace. 15 New Haven (358), Hartford (293), Bristol (200), New Britain (179), Bridgeport (137), Enfield (127) and West Hartford (122) were on the other end of the spectrum. The number 45 was selected to 16 be more in line with other communities of our size. 17 18 A majority of the Commission also believed that increasing the number of Justices of the Peace 19 20 would allow more racial, ethnic and gender diversity among the Justices of the Peace and allow 21 the appointment of individuals from various communities within Manchester. Currently, there is only one Spanish speaking Justice of the Peace in Manchester available to perform ceremonies in 22 a native language. Under state law, this change would allow for 15 Democratic appointments, 15 23 24 Republican appointments and the appointment of 15 electors who are not registered as 25 Democrats or Republicans. 26 27 Charge # 3. Review of Section 9-1 of the Town Charter, Election to Board of Education to consider revision of the terms of office. 28 29 Recommendation: The Charter Revision Commission voted 5-3-3 on February 23, 2022, to take 30 no action on this charge. 31 32 33 Discussion/Rationale: The Commission discussed various alternatives for election of members of the Board of Education, including: 2-year terms, 4-year terms or maintaining the current 3-year 34 35 terms. On a divided vote, the Commission recommend no action on this charge, thus maintaining the current 3-year terms for members of the Board of Education. 36 37 38 Charge # 4. Review of Section 14-1 of the Town Charter, Recreation and Park Commission, 39 to consider increasing the membership of the commission from 7 members to 9 members. 40 Recommendation: The Charter Revision Commission voted 10-0 on March 21, 2022, to 41 recommend that Sections 2-2, 14-1, 14-2 and 14-3 of the Town Charter be amended to remove 42

Discussion/Rationale: The Commission believes that the Advisory Recreation and Park Commission, as its name implies, is advisory in nature and, as such, would be better established by ordinance or resolution. The Commission recognizes the important role of the Commission and encourages the Board of Directors to reestablish it through ordinance or resolution, which can update its mission and adjust the size of the membership, if deemed necessary.

5A. Board of Directors - Terms of Office

- Recommendation: The Charter Revision Commission voted 10-1 on January 31, 2022, to
 maintain the existing 2-year term of office for members of the Board of Directors.
- Discussion/Rationale: The Commission supported maintaining the current 2-year term for
 members of the Board of Directors as they believe that it effectively promotes accountability to
 the citizens of Manchester.

5B. Board of Directors - Compensation

Recommendation: The Charter Revision Commission voted 10-0 on March 21, 2022, to recommend that of Section 3-3 of the Town Charter be amended increase compensation for the Board of Directors as follows: Mayor - \$7,500; Deputy Mayor, Secretary and Minority Leader -\$6,000; members of the Board of Directors - \$5,000 and such compensation shall be adjusted biennially, at the beginning of a new term of office, by the most recent Consumer Price Index for All Urban Consumers (CPI-U) published by the U.S. Bureau of Labor Statistics. (*See draft language, Appendix p. 29*)

- **Discussion/Rationale:** Compensation for members of the Board of Directors has not been increased since 1996. This recommendation would provide the first increase in 26 years and would tie future increase to a cost-of-living index. The recommendation also includes enhanced compensation for the Minority Leader.

Discussion/Rationale: After assessing the pros and cons of electing some offices by district or ward, it was believed that it would be difficult to implement logistically and that the current atlarge system works effectively for Manchester.

Review of Section 3-1 of the Town Charter with respect to the formulation of 19 boards and commissions and the appropriateness of establishing those bodies by resolution 20 or ordinance instead, so as to have flexibility in amending their structure and responsibilities 21 absent charter revision. 22 23 Recommendation: The Charter Revision Commission voted 10-0 on March 21, 2022, to remove 24 the following boards and commissions from the Town Charter and allow the Board of Directors to 25 establish those bodies by resolution or ordinance instead: 1) Library Board (Sections 2-2, 16-1 26 and 16-2); 2) Advisory Recreation and Park Commission (Sections 2-2, 14-1, 14-2 and 14-3); and 27 3) the Advisory Board of Health (Sections 2-2 and 15-1). (See draft language, Appendix pp. 30 -28 33 29 Discussion/Rationale: The Commission believes that the Library Board, the Advisory Recreation 30 and Park Commission and the Advisory Board of Health are advisory in nature and, as such, would 31 32 be better established by ordinance or resolution. The Commission recognizes the important role 33 of each of these bodies and encourages the Board of Directors to reestablish each through 34 ordinance or resolution, which can update their missions and adjust the size of their membership, 35 if deemed necessary. The Commission also recommends that other Boards and Commissions with statutory authority remain in the Charter, specifically, the Planning and Zoning Commission, 36 37 Zoning Board of Appeals, Board of Assessment Appeals and the Ethics Commission. 38 39 Charge # 9. Review of Section 4-5 of the Town Charter, General Manager appointments as 40 opposed to Board of Directors appointments, not otherwise required by state or federal law. 41 42 **Recommendation:** The Charter Revision Commission voted 11-0 on February 23, 2022, to take 43 no action on this charge. 44

1	Discussion/Rationale: Under current practice, the General Manager makes appointments to the
2	following: the Conservation Commission, the Economic Development Commission, the
3	Permanent Memorial Day Committee, and the Veterans Graves Custodians. The General Manager
4	also nominates individuals for the Redevelopment Commission, however, those members are
5	approved by the Board of Directors.
6	
7	State law vests the appointing authority for appointment of the Conservation Commission (Section
8	7-131a of the Connecticut General Statutes) and the Economic Development Commission
9	(Section 7-136 of the Connecticut General Statutes) in the chief executive authority of a
10	municipality, which for Manchester is the General Manager, so there does not appear to be any
11 12	flexibility to make a change.
13	Charge # 10. Review of Section 3-1 of the Town Charter, powers of the Board of Directors,
14	to provide the Board of Directors with the ability to draft proposals absent the direction of
15	the General Manager.
16	
17	Recommendation: The Charter Revision Commission voted 11-0 on February 23, 2022, to take
18	no action on this charge.
19	
20	Discussion/Rationale: Similar to our conclusion on Charge # 7, we believe that the Board of
21	Directors has sufficient authority to accomplish this within their authority as a legislative or policy-
22	making body.
23	
24	Charge # 11. Review of Section 3-5 of the own Charter, powers of the Board of Directors, to
25	clarify leadership including succession in the event of the resignation of the Chairman/Mayor
26	of the Board of Directors.
27	
28	Recommendation: The Charter Revision Commission voted 10-0 on March 21, 2022, to
29	recommend that Section 2-11 of the town Charter be amended to provide that in the event of the
30	death or resignation of the chairman of the Board of Directors, the Vice Chairman shall become
31	<u>Chairman.</u> (See draft language, Appendix p. 34)
32	
33	Discussion/Rationale: The Commission believes that it is important to clarify the Charter
34	regarding leadership succession on the Board of Directors in the event of the death or resignation
35	of the Chairman of the Board of Directors.
36	
37	Charge # 12. Review of Section 3-1 of the Town Charter, to review training opportunities and
38	possible requirements for members of boards and commissions.
39	
40	Recommendation: The Charter Revision Commission voted 11-0 on January 31, 2022, to not
41	include this item in the Town Charter but recommends that the General Manager and town staff
42	develop training for members of Boards and Commissions and create a handbook for newly
43	appointed members of Boards and Commissions.
44	

Discussion/Rationale: The Commission suggests creation of a guide similar to a document 1 2 produced by the Town of West Hartford, Office of Corporation Counsel entitled "Welcome to Public Service: A Short Guide to Public Service as a Town of West Hartford Elected or Appointed 3 4 Officials" 5 https://resources.finalsite.net/images/v1553089648/westhartfordctgov/zaranbmia8y6ybbrtpe u/WelcometoPublicService.pdf 6 7 8 Charge # 13. Review of Chapter III and Chapter IV of the Town Charter, to consider the 9 structure of the council-manager form of government. 10 **Recommendation:** The Charter Revision Commission voted 10-1 on January 31, 2022, to 11 12 maintain the existing council-manager form of government. 13 14 Discussion/Rationale: The Council/Manager form of government has served Manchester well for the past 75 years. It provides the Town with capable, consistent, and professional 15 management. It is also noted that there was strong support for the Council/Manager form of 16 government at our January 5th public hearing. 17 18 19 **OTHER ISSUES CONSIDERED BY THE CHARTER REVISION COMMISSION** 20 21 Method of Filling Vacancies of Elected Officials and Members of Boards and Commissions 22 23 **Recommendation:** The Charter Revision Commission voted 10-0 on March 21, 2022, to 24 25 recommend that Section 2-11 of the Town Charter be amended to provide that minority party vacancies on the Board of Directors and on appointed boards and commissions require that the 26 nomination be made by member of the Board of Directors with the same political party affiliation 27 as the vacating member. (See draft language, Appendix pp. 35 - 36) 28 29 30 Discussion/Rationale: The Commission believes that the Charter should reflect the spirit of the 31 minority representation law (Section 9-167a of the Connecticut General Statutes) and minority 32 party vacancies on the Board of Directors and on appointed boards and commissions require that 33 the nomination be made by member of the Board of Directors with the same political party affiliation as the vacating member. Such nominations will still require action by the Board of 34 Directors. 35 36 37 Increase the Membership of the Planning and Zoning Commission 38 39 Recommendation: The Charter Revision Commission voted 10-0 on March 21, 2022, to increase the membership of the Planning and Zoning Commission to 9 members. (See draft language, 40 41 Appendix p. 37 42

1	Discussion/Rationale: Given the important role of the Planning and Zoning Commission in land
2	use matters it is believed that it would be beneficial to increase the membership within the
3	parameters established in Section 8-4a of the Connecticut General Statutes.
4	
5	Changing the Name of the Board of Directors to Town Council
6	
7	Recommendation: A motion to change the name of the Board of Directors failed on a tie (5-5)
8	vote on March 21, 2022. This action maintains the current name of the Board of Directors in the
9 10	<u>Charter</u> .
11	Discussion/Rationale: There was insufficient support among members of the Commission to
12 13	change the name of the "Board of Directors" to "Town Council."
14	Changing the Title of the General Manager to Town Manager
15	
16	Recommendation: The Charter Revision Commission voted 9-1 on March 21, 2022, to change
17	the title of the "General Manager" to "Town Manager." (See draft language, Appendix pp. 38 - 53)
18	
19	Discussion/Rationale: This change is being made to reflect the more conventional nomenclature
20	for the job title.
21	
22	Changing the Official Name of the Town of Manchester to the City of Manchester
23	
24	Recommendation: The Charter Revision Commission voted 11-0 on April 6, 2022, to
25	recommend that the Board of Directors consider the establishment of a Commission to study
26	whether the official name of the "Town of Manchester" be changed to the "City of Manchester."
27	Such Commission should be empowered as a Charter Revision Commission to examine the legal
28	and economic impacts of such a name change and make recommendations regarding the issue
29	to the Board of Directors.
30 24	Discussion (Detional to This issue requires more outenaive rescards and evaluation then the
31 22	Discussion/Rationale: This issue requires more extensive research and evaluation than the current Charter Revision Commission can complete prior to its deadline. It may be necessary for

(See draft language, Appendix p. 54) 11 Discussion/Rationale: This recommendation establishes a deadline for the Board of Directors 12 13 to establish the Town Clerk's salary well in advance of the election and the beginning of a new term of office. 14 15 Town Clerk and Registrars of Voters - Clarify 4-year Terms 16 17 Recommendation: The Charter Revision Commission voted 11-0 on April 6, 2022, to 18 19 recommend that Section 2-1 of the Town Charter be amended to conform the Charter with the provisions of Section 63-2 of the Town Code of Ordinances to specify four-year terms for the 20 21 Town Clerk and Registrar of Voters. (See draft language, Appendix p. 55) 22 **Discussion/Rationale:** This recommendation conforms the Charter with current practice that 23 has been in place for over 40 years under Section 63-2 of the Town Code of Ordinances. This 24 ordinance was enacted under the authority of Section 9-189a of the Connecticut General 25 26 Statutes. 27 **Direct Election of Mayor** 28 29 30 **Recommendation:** The Charter Revision Commission voted 11-0 on April 18, 2022, to recommend that Sections 2-1 and 3-2 of the Town Charter be amended to provide for the direct 31 election of Mayor. The Mayor shall remain a member of the Board of Directors and electors will 32 also select the remaining 8 members of the Board of Directors, however, the losing mayoral 33 34 candidates shall have the votes they received for Mayor included in the compilation and the determination of Board of Directors membership. Minority representation requirements will still 35
- 36 apply. (See draft language, Appendix p. 56)

- **Discussion/Rationale:** The Commission's recommendation seeks to provide direct voter involvement in the selection of the Mayor. While the 2008 Charter revision did specify that the top vote getter for the Board of Directors shall be the Mayor, there are concerns that the ballot placement due to a position lottery and the potential for "bullet voting" don't provide electors with a clear choice when voting. The Commission recommends a system utilized in the Town of Berlin and a number of other communities throughout Connecticut which provides for political parties to nominate, and for others to petition, individual candidates for the position of Mayor. Allow the Board of Directors to Adopt Additional Standards of Official Conduct by Ordinance

Recommendation: The Charter Revision Commission voted 11-0 on April 18, 2022, to

 with the authority, pursuant to sections 7-148h and 7-148 (c)(10)(B) of the Connecticut General
 Statutes, as amended, to establish by ordinance additional standard of official conduct. (*See draft language, Appendix pp. 57 - 60*)

Discussion/Rationale: The Commission reviewed a recommendation of the 2008 Charter 13 14 Revision Commission that was rejected by the voters that would have removed the Standards of 15 Official Conduct from the Town Charter and would have allowed a supermajority of the Board of Directors to adopt Standards of Official Conduct by ordinance. After discussion, the Commission 16 voted to retain the Standards of Official Conduct in the Charter but to also allow the Board of 17 18 Directors to add additional standards by ordinance. This would have the effect of maintaining the 19 core standards in the Charter but would provide greater flexibility in enacting additional standards 20 without waiting for the next Charter Revision process, which typically has been approximately 21 every 10 or 15 years. 22

23 **Residency Requirements**

Recommendation: The Charter Revision Commission voted 11-0 on April 18, 2022, to
 recommend that Sections 9-3, 10-1, 10-12, 11-3 and 12-4 of the Town Charter be amended to
 eliminate residency requirements for the Superintendent of Schools, Chief of Police, Fire Chief,
 Director of Public Works, and the Superintendent of Water and Sewer Department. (See draft
 language, Appendix pp.61 - 62)

Discussion/Rationale: The Commission recommends that the residency requirement be maintained for the General Manager but that other residency requirements should be removed from the Charter. Compelling arguments were made that residency requirements may provide a barrier in recruiting the most capable candidates for key positions in Town government and the Board of Education. The Commission encourages the Board of Directors and the Board of Education to include proximity requirements, such as residing within a certain geographic area or having a commute of a certain duration, in the job descriptions for these positions.



4 Sec. 2-1 Elective officers. 5 A meeting of the electors of the Town of Manchester for the election of Town officers shall be held on the first Tuesday after the first Monday in November 1969, and biennially thereafter. At 6 each such meeting there shall be elected nine (9) members of the Board of Directors, a Town Clerk, 7 two (2) Registrars of Voters elected in the manner prescribed by the General Statutes, three (3) 8 9 [Selectmen] MEMBERS OF THE SELECT BOARD, seven (7) Constables, and members of the Board of Education as hereinafter provided. Further, all legislative rights, powers and duties of the Town and the powers of 40 appointment to all boards, agencies and commissions not otherwise vested by this Charter are 41 42 exclusively vested in the Board of Directors. It shall have, in addition to all powers and duties 43 conferred and imposed upon it by this Charter, all the powers and duties now or hereafter conferred or imposed by the General Statutes on Town boards of selectmen, relating to the abatement of 44 45 taxes. The final authority concerning a budget and tax rate is vested exclusively in the Board of Directors subject to the provisions of §§ 3-10 and 3-13 of this chapter. The Board of Directors 46

shall have the power to investigate any and all departments, offices and agencies of the Town. For 1 the purposes of such investigation, the [Chairman] CHAIR or Acting [Chairman] CHAIR shall 2 have the power to administer oaths and issue subpoenas and, at [his] THEIR request, any judge 3 4 may issue a capias for the appearance of witnesses and the production of books and papers except as herein provided. The Board of Directors shall hold a special meeting to review the 5 administrative performance of the General Manager between June 1 and July 31 of each year. 6 Except to the extent to which such powers are conferred upon the Town Planning Commission, 7 the Board of Directors shall exercise the powers hitherto possessed by the Town meeting and the 8 Board of Selectmen relative to the collection of benefits due the Town from the establishment of 9 any building, street, sidewalk or curb or tree line or benefits accruing from the opening or 10 improvement of any street or highway, including the assessment of a portion of the cost thereof on 11 the owners of abutting property, and such powers are extended to include the construction and 12 assessment of the cost of highways, sidewalks, curbs, gutters, sewers and drains. The Board of 13 Directors shall have the power to make, alter and repeal ordinances and bylaws, not inconsistent 14 with this Charter or the General Laws of the state, for the execution of the powers vested in the 15 Town as provided in Chapter I of this Charter, for the government of the Town and the 16 17 management of its business and for the preservation of the good order, peace, health and safety of the Town and its inhabitants. Such ordinances and bylaws shall be binding upon all the inhabitants 18 of the Town and upon persons coming within its limits, and said Board may provide penalties for 19 20 breaches thereof not exceeding one hundred dollars (\$100.00) for each offense. Notwithstanding any other provisions of this Charter, the Board of Directors, subject to the general laws of the state, 21 shall have the authority to establish, delete or alter departments and divisions comprising the 22 internal organizational structure of the Town deemed necessary to effectively and efficiently 23 perform the duties of those departments and functions specifically mentioned within the provisions 24 of this Charter and to make such rules and regulations: 25

- 27 (a) Concerning the creating or abolishing of departments and offices,
- 28
- 29 (b) Regulating the internal operation of departments, offices and personnel,

(c) Fixing the compensation of officers and employees of the Town and the charges, if any, to be
 made for services rendered by the Town, as it may deem to be in the best interest of the Town. The
 Board of Directors shall have the power to designate the General Manager as the personnel and
 office manager for the Town and to require that all such office and personnel matters shall be
 administered by [him] THE GENERAL MANAGER in accordance with the rules and
 regulations adopted by the Board of Directors.

38 The Board of Directors may fix the charges, if any, to be made for services rendered by the Town 39 or for the execution of powers vested in the Town as provided in Chapter I of this Charter and the 40 General Statutes, as amended. The Board of Directors shall establish ordinances and regulations 41 regarding such charges.

- 43 The Board of Directors shall authorize all purchases of real estate by the Town and all sales of real
- 44 estate owned by the Town by ordinance, which ordinance shall be enacted in compliance with §
- 45 3-8 and shall be subject to the provisions of §§ 3-9 and 3-10, except that all sales and purchases
- 46 connected with redevelopment and urban renewal as provided in Chapter 130 of the Connecticut

General Statutes, Revision of 1958, as amended, and all condemnation proceedings and
 acquisition, sale or exchange of easements necessitated by public improvement projects of the
 Town authorized by the Board of Directors are excluded from the operation of this section.

5 Sec. 3-3 Compensation.

6 The compensation of the members of the Board of Directors shall be as follows: the [Chairman]

- 7 <u>CHAIR</u> shall be paid three thousand dollars (\$3,000.00) annually, the [Deputy Chairman] <u>VICE</u>
- 8 <u>CHAIR</u> and the Secretary shall be paid two thousand four hundred dollars (\$2,400.00) annually,
- 9 and the other members of the Board shall be paid two thousand dollars (\$2,000.00) annually, which

12 Sec. 3-4 Organization.

- 13 The Board of Directors shall meet in the afternoon on the third Monday in November, 1969, and

- 16 years Vice [Chairman] CHAIR of the Board of Directors; and one of its own members to be for a

37 Sec. 3-6 Secretary.

- 38 The Secretary shall have charge of keeping a correct public record of all meetings of the Board, 39 which record shall be open to inspection at all reasonable times by any taxpayer or elector of the 40 Town. Upon authorization by the Board of Directors, the Secretary or the [Chairman] CHAIR 41 may sign, on behalf of the Board, all formal notices and records. The Secretary shall have no power 42 to sign contracts. The Town Clerk may certify the records of the Board of Directors as true copies
- 43 of the records of the Board of Directors as kept by the Secretary.

45 Sec. 3-11 Revision of existing ordinances.

1 The provisions of §§ 3-8 and 3-9 of this chapter shall not apply to any ordinance or bylaw adopted

At the meeting of the Board of Directors on the first Monday in November, 1948, or as soon 10 11 thereafter as possible, the Board of Directors shall appoint a General Manager who shall be chosen on the basis of [his] THEIR executive and administrative qualifications with special reference to 12 [his] THEIR actual experience in, and [his] THEIR knowledge of, accepted practices in respect 13 to the duties of [his] THEIR office as herein set forth. At least thirty (30) days before such removal may be made effective, the Board of 23 Directors shall, by such a majority vote of its members, adopt a preliminary resolution stating the 24 reasons for the proposed removal, and a copy of such resolution shall forthwith be mailed by 25 26 registered mail to the General Manager at [his] THEIR usual place of abode. The General Manager may reply and may appear and be represented by counsel at a public hearing which shall be called 27 by the Board of Directors if requested by the General Manager. If the General Manager shall be found guilty by any 40 court of misfeasance or malfeasance in office or of any felony, [he] THE GENERAL 41 42 MANAGER may be summarily dismissed by the Board of Directors, and [he] THE GENERAL MANAGER shall not be entitled to any salary other than any unpaid balance which may be due 43 [him] THE GENERAL MANAGER. 44

46 Sec. 4-4 Absence or disability of General Manager.

 To perform the duties of the General Manager pending the appointment of a General Manager or during [his] <u>THE GENERAL MANAGER'S</u> temporary absence or disability, the Board of Directors may appoint an Acting Manager, who shall not be one of its own members, to perform the duties of the General Manager.

6 Sec. 4-5 General Manager, powers and duties.

The General Manager shall be the chief executive officer and the head of the administrative branch 7 of the Town government, and none of the administrative duties of the Town shall be performed by 8 any member of the Board of Directors. All administrative rights, powers and duties of the Town 9 not otherwise vested by this Charter are exclusively vested in the General Manager. Except for the 10 appointment of boards, agencies and commissions provided for by the General Statutes and except 11 as herein provided, he shall exercise the powers and perform the duties in and for the Town of 12 Manchester which are conferred and imposed by law upon selectmen, except as to the filling of 13 vacancies in elective offices as set forth in § 2-11 hereof and to the delivery and filing of the 14 welfare reimbursement agreements and liens referred to in Sections 17-280 and 17-281, 1958 15 Revision of the General Statutes.^[1] The service of any process against or notice to the Town, and 16 any notice which the General Statutes may provide, should be served upon the selectmen or any 17 selectman of a Town shall, in the case of the Town of Manchester, be served upon the Town Clerk. 18 The General Manager shall have charge of the preparation of the annual report of the Town 19 20 required by law, shall attend meetings of the Board of Directors, may participate in any discussion and may make recommendations but shall not have the right to vote at such meetings. In addition 21 to the duties prescribed by this Charter, [he] THE GENERAL MANAGER shall perform such 22 23 other duties as may be required of [him] THE GENERAL MANAGER by the Board of Directors not inconsistent with the provisions of this Charter. 24

26 Sec. 4-6 Delegation of authority during vacancy of office.

Unless otherwise specially provided for in this Charter, the General Manager shall have the power
 to delegate any person to be the acting head of any department, commission, bureau or board
 appointed by [him] THE GENERAL MANAGER during the period of any vacancy, absence or
 disability and until a new appointment shall have been made.

32 Sec. 5-2(a) Preparation.

33 The General Manager shall prepare and, not less than 110 days prior to the beginning of each fiscal year, shall submit to the Board of Directors a tentative budget for the ensuing fiscal year and an 34 explanatory budget message. Such tentative budget shall, where possible, include a statement of 35 receipts during the last completed fiscal year, the receipts for the first six (6) months of the current 36 fiscal year, an estimation of receipts for the entire fiscal year and an estimation of receipts during 37 the ensuing fiscal year, all itemized in accordance with a classification approved by the Board of 38 39 Directors. later than February 14 of each year, submit to the General Manager a request for an appropriation 1 for the ensuing year in accordance with a form prescribed by the General Manager and shall furnish 2 the General Manager with such further information as to receipts and expenditures as [he] THE 3 4 GENERAL MANAGER shall require. The request for an appropriation filed by the Board of Education with the General Manager shall be accompanied by a copy thereof for each member of 5 the Board of Directors. Within three (3) days of filing the request for an appropriation, the Chair 6 of the Board of Education may submit a letter to the General Manager requesting joint meeting of 7 the two (2) Boards for the purpose of discussing the appropriation request of the Board of 8 Education and the recommendations of the General Manager. If the Chair of the Board of 9 Education requests this initial joint meeting, the joint meeting shall be held not later than five (5) 10 days before the General Manager submits [his] A tentative budget to the Board of Directors. 11 Following the submittal of the General Manager's tentative budget, but not later than seven (7) 12 days before the adoption of the final budget, a mandatory joint meeting of the two (2) Boards shall 13 be held for the purpose of presenting and discussing the appropriation request of the Board of 14

17 Sec. 5-2(b) Submission to Board of Directors.

The <u>GENERAL</u> Manager shall prepare and submit to the Board of Directors a six-year capital
 improvement program as part of the tentative budget.

21 Sec. 5-13 Director of Finance to assume former powers and duties of Town Treasurer.

The Director of Finance shall have all the powers and perform all the duties which are vested by 22 statute in town treasurers, and, except as otherwise provided in this Charter, as amended, all the 23 powers and duties which were formerly vested in the Town Treasurer by this Charter. [He] THE 24 **DIRECTOR OF FINANCE** shall have custody of and disburse all funds belonging to the Town 25 and shall deposit the same in such banks and trust companies as may be designated by the Board 26 of Directors on the recommendation of the General Manager. [He] THE DIRECTOR OF 27 FINANCE shall keep such books and records as the Board of Directors shall prescribe. [He] THE 28 **DIRECTOR OF FINANCE** shall be the Treasurer of the Town Deposit Fund and shall have 29 authority to invest and reinvest the same in securities legal for investment of trust funds under the 30 General Statutes. Nothing herein shall be construed to prevent sinking funds and trust funds from 31 continuing to be managed by any trust company managing them at the effective date of this Charter 32 33 unless the appointment is revoked by the Board of Directors. Whenever a vacancy occurs, or any trust fund is hereafter created, the Board of Directors shall have power on the recommendation of 34 the General Manager to designate a trust company or trust companies to manage the same, which 35 designation shall continue until revoked. The Director of Finance or Acting Director of Finance 36 and the General Manager or Acting General Manager jointly shall have the power to endorse, 37 negotiate, sign and transfer, on behalf of the Town, any securities in order to effectuate the transfer 38 39 thereof.

41 Sec. 5-17 Purchases and contracts.

42 With the exception of the Board of Education, no officer or employee of the Town shall make any

10 Sec. 6-1 Collector of Revenue.

The Collector of Revenue shall be appointed by the General Manager and shall receive and collect all taxes and assessments payable to the Town and such other fees and charges as may be assigned to [him] THE COLLECTOR OF REVENUE for collection by the Board of Directors on the recommendation of the General Manager. Except as otherwise provided in this Charter, [he] THE

15 COLLECTOR OF REVENUE shall have such powers and duties as are conferred or imposed

16 on tax collectors of towns by the General Statutes. In addition to any other persons designated by

- 17 the Charter, the Collector of Revenue shall have the power to execute and release all liens provided

20 Sec. 7-2 Voting districts.

The Town may by ordinance establish voting districts. Whenever voting districts are established, each elector of the Town shall vote in the district in which [he] SUCH ELECTOR resides. The Registrars of Voters of the Town shall prepare a list of the electors in each voting district, listing the name of each such elector and [his] THEIR residence by street and number, if possible. The Registrar of Voters shall prepare similar lists of electors who are registered with each political party, or may combine such registration list with the list of the electors by indicating on the list of

37 The General Manager shall appoint a Chief of Police who at the time of [his] THEIR appointment need not be a resident of the Town or state but within one (1) year of appointment shall reside 38 39 within the Town. The Chief of Police shall be the executive head of the Police Department and, as such, shall have charge and control, under the direction of the General Manager, of the 40 administration and discipline of the Police Department and of its buildings, property, apparatus 41 42 and equipment. The Chief shall appoint such subordinate officers and members of the personnel 43 in the Police Department, including supernumerary and special police, as [he] THE CHIEF may deem necessary and shall fix their compensation within a scale of wage rates recommended by 44 45 [him] THE CHIEF and approved by the General Manager and within the appropriations made by

46 the Board of Directors. The Chief shall have control over traffic and traffic regulations and shall

1 be the traffic authority of the Town with all the powers and duties within the Town vested in and

2 imposed upon traffic authorities by the General Statutes. [He] THE CHIEF shall make and

3 enforce such reasonable rules, orders and regulations, not inconsistent with the General Statutes

4 and the provisions of this Charter, as may be necessary efficiently to exercise all the powers and

- 5 duties imposed upon and vested in [him] THE CHIEF and the Department, including the duties
- and discipline of the personnel of the Department. [He] THE CHIEF shall have authority to
 administer oaths and take evidence in all proceedings relating to the direction and control of the
- Police Department.

10 Sec. 10-2 Qualifications of policemen.

No person shall be appointed to the police force nor as a supernumerary or special policeman unless [he is] <u>THEY ARE</u> of good moral character and habits and in good health and until [he] <u>THEY</u> shall have passed such examination respecting his educational, physical and general qualifications as may be prescribed by the Chief of Police with the approval of the General Manager.

17 Sec. 10-3 Removal of policemen.

18 The Chief of Police shall have the power to remove, expel, suspend, reduce in rank or otherwise 19 deal with officers of all ranks and regular, supernumerary and special members of the police when 20 in [his] <u>THE CHIEF'S</u> opinion the best interests of the Department require such action. Any 21 officer or member of the Police Department thus subjected to disciplinary action shall be entitled 22 upon request in writing to the General Manager to a public hearing before the General Manager 23 under such procedure as the General Manager shall provide.

25 Sec. 10-4 Powers and duties of policemen.

26 The Chief, officers and members of the Police Department shall have in criminal matters all the powers of police officers under the General Statutes, and shall also have the power to arrest any 27 person found by them violating any of the laws of the state or the penal ordinances of the Town. 28 Such person shall be dealt with in the same manner as if [he] THEY had been arrested upon a 29 warrant theretofore duly issued. All criminal process for any offense committed within the Town, 30 and all process to recover or to enforce any penalty for the violation of any Town ordinance issued 31 out of any court, or by any judge within the Town, and each process, subpoena or bench warrant 32 33 issued by the State's Attorney of Hartford County, relating to any offense committed within said Town, may be served by any member of the Police Department. The members of said Department 34 shall possess such powers and perform such other duties as may be provided by law or ordinance. 35 36

37 Sec. 10-5 Political activity prohibited.

No officer or member of the Police Department shall be a member of any political committee or delegate to any political convention, nor shall be hold any elective or other appointive position in the local government except that of Animal Control Officer or Assistant Animal Control Officer.
[He] <u>THEY</u> shall not solicit any person to vote at any political primary, caucus or election, nor in any way or manner attempt to influence the vote of any elector thereat. Violation of any provision of this section shall constitute a cause for dismissal or suspension.

45 Sec. 10-12 Town Fire Department.

The General Manager shall appoint a Fire Chief who at the time of [his] THEIR appointment need 1 not be a resident of the Town or state, within one (1) year of appointment shall reside within the 2 Town. [He] THE CHIEF OF THE FIRE DEPARTMENT shall be the executive head of the 3 4 Fire Department and as such shall have charge and control, under the direction of the General Manager, of the administration and discipline of the Fire Department and of its buildings, property, 5 apparatus and equipment. The Chief of the Fire Department shall appoint such subordinate officers 6 and members of the personnel of the Fire Department as he may deem necessary and shall fix their 7 compensation within a scale of wage rates recommended by him and approved by the General 8 Manager and within the appropriations made by the Board of Directors. The Chief of the Fire 9 Department shall make and enforce such reasonable rules, orders and regulations, not inconsistent 10 with the General Statutes and the provisions of this Charter, as may be necessary efficiently to 11 exercise all the powers and duties imposed upon and vested in him and the Department, including 12 the duties and discipline of the personnel of the Department. Nothing herein shall be construed to 13 prevent the continuance of volunteer fire companies, together with such paid assistants as may be 14 deemed advisable. 15

17 Sec. 11-3 Director of Public Works; powers and duties.

The General Manager may appoint and may remove a Director of Public Works who at the time 18 of [his] THEIR appointment need not be a resident of the Town or state but within one (1) year 19 20 of appointment shall reside within the Town. The Director of Public Works shall be experienced in the management of municipal public works projects and shall be responsible for the efficiency, 21 discipline and good conduct of the Department and in accordance with such personnel rules and 22 regulations as may be adopted by the Board of Directors or included in this Charter, shall appoint 23 and may remove such deputies, assistants and employees as [he] THEY may deem necessary 24 within budget appropriations and shall prescribe their duties. [He] THE DIRECTOR OF 25 26 **PUBLIC WORKS** shall exercise [his] **THEIR** powers and discharge [his] **THEIR** duties under the general supervision of the General Manager. [He] THE DIRECTOR OF PUBLIC WORKS 27 shall organize the work of the Department and establish such divisions within the Department in 28 such manner as [he] THEY shall deem most economical and efficient, provided the Director of 29 Public Works may, at [his] THEIR discretion, serve as head of any such divisions. The Director 30 of Public Works shall make recommendations as to the acceptance of streets sought to be dedicated 31 to public use. 6 All property, both real and personal, all rights and action and rights of every description and all securities and liens vested or inchoate in said Town as of the date when this Charter shall take 7 effect are continued in said Town, and said Town shall continue to be liable for all debts and 8 9 obligations of every kind for which said Town shall be liable on said date, whether accrued or not. Nothing herein shall be construed to affect the right of said Town to collect any assessment, charge, 10 debt or lien. If any contract has been entered into by said Town prior to the effective date of this 11 Charter or any bond or undertaking has been given by or in favor of said Town which contains 12 provision that the same may be enforced by any officer, board, commission, bureau or department 13 therein named, which is hereby abolished, such contracts, bonds or undertakings shall be in no 14 15 manner impaired but shall continue in full force and effect and the powers conferred and the duties imposed with reference to the same upon any such officer, board, commission, bureau or 16 department shall, except as otherwise provided in this Charter, thereafter be exercised and 17 discharged by the [General] TOWN Manager 18

20 Sec. 2-2 Officers appointed by the Board of Directors.

21 There shall be appointed by the Board of Directors for the Town a [General] TOWN Manager, a Planning and Zoning Commission consisting of five (5) members, a Zoning Board of Appeals 22 consisting of five (5) members, and alternates as provided by statute, a Library Board consisting 23 of eleven (11) members, a Board of Tax Review consisting of three (3) members, a Town Attorney, 24 an Advisory Recreation and Park Commission consisting of five (5) members, an auditor or 25 auditors, and an Advisory Board of Health. The Town may by ordinance or resolution approved 26 by the Board of Directors provide for other offices, departments, boards and commissions and the 27 28 duties and terms thereof and methods of appointment thereto. 38 Sec. 2-7(b) Blanket bonds.

The Board of Directors shall purchase two (2) blanket bonds, one (1) conditioned for faithful performance of duty which shall include the [General] TOWN Manager, Purchasing Agent, and such other officers and employees as may be designated by the Board of Directors; and one (1) conditioned to protect against loss occasioned by embezzlement or any other dishonest act and to include those eligible officers and employees not included in the faithful performance blanket bond. The penal sum of these blanket bonds shall be fixed by the Board of Directors and to be in a form to be prescribed or approved by the Town Attorney and filed with the Town Clerk.

46 Premiums for said bonds shall be paid by the Town.

2 Sec. 2-9 Removal from office by [General] TOWN Manager.

The [General] TOWN Manager may remove any officer or employee appointed by him when, in 3 4 his opinion, the best interests of the Town require such action, provided the officer or employee shall have been served with a written notice of the intention of the [General] TOWN Manager to 5 remove him, containing a clear statement of the grounds for such removal. Any officer or employee 6 so discharged shall be entitled, upon request in writing to the Board of Directors, to a hearing 7 before said Board under such procedure as said Board shall provide, which hearing shall be public 8 at the option of such officer or employee and at which he may be represented by counsel, but the 9 final decision with respect to any such discharge or removal shall rest with the [General] TOWN 10 11 Manager. 19 Resignations of all officers and members of boards and commissions appointed by the Board of 20 Directors shall be presented to the Board of Directors, and resignations of all officers and members 21 of boards and commissions appointed by the [General] TOWN Manager shall be presented to the 22 [General] TOWN Manager. Resignations of elective officers shall be presented to the Board of

23 Directors, except that resignations from the Board of Education shall be presented to that Board.

25 Sec. 3-5 Chairman and Vice Chairman.

39 No ordinance or bylaw adopted by the Board of Directors, except those making appropriations, or fixing the tax rate, as provided in Chapter V of this Charter, shall become effective until it shall 40 have been advertised in full or summarized in accordance with provisions contained in State 41 42 Statutes at least three (3) times in a newspaper having a general circulation in the Town and a 43 period of ten (10) days from the date of the third such advertisement shall have elapsed, during which ten (10) days no petition for a referendum on the ordinance shall have been filed in 44 45 accordance with the provisions of this section. If, within ten (10) days after the third publication of any such ordinance, a petition signed by not less than five (5) percent of the electors of the 46

Whenever a petition signed by not less than five (5) percent of the electors of the Town, as 13 determined from the latest official lists of the Registrars of Voters, proposing any lawful 14 appropriation, ordinance or bylaw and including the complete text of any such ordinance or bylaw 15 is filed with the Town Clerk requesting its passage, the Town Clerk shall, within ten (10) days 16 17 thereafter, certify such petition and proposed ordinance or bylaw to the Board of Directors for its consideration. If, within forty-five (45) days from such certification, the Board of Directors shall 18 not have made such appropriation or passed such ordinance or bylaw, or one substantially similar 19 20 thereto, the Town Clerk shall submit such proposed ordinance or bylaw to the Town Attorney who shall, not later than thirty (30) days from the date the Town Clerk submits such proposed ordinance 21 or bylaw to the Town Attorney, without materially changing its meaning and effect, correct the 22 wording to avoid repetition, illegalities and unconstitutional provisions and assure accuracy and 23 clarity. 34 Sec. 3-11 Revision of existing ordinances.

The provisions of §§ 3-8 and 3-9 of this chapter shall not apply to any ordinance or bylaw adopted by the Board of Directors which is substantially similar in language to any ordinance or bylaw of the Town adopted prior to January 1, 1947, except that the Board of Directors or [General] TOWN Manager is substituted for the Board of Selectmen or the Chairman of the Board of Directors is substituted for the Chairman of the Board of Selectmen. Any such ordinance or bylaw shall be effective upon passage by the Board of Directors and filing with the Town Clerk without the necessity of public hearing or advertisement.

43 Sec. 3-12 Joint annual meeting of Board of Directors and Board of Education.

42 Sec. 4-5 [General] <u>TOWN</u> Manager, powers and duties.

43 The [General] TOWN Manager shall be the chief executive officer and the head of the

The [General] TOWN Manager shall cause a summary of the tentative budget and 11 budget message to be advertised in the same manner as provided for giving notice of a public 12 hearing in § 3-8 of this Charter. The third such advertisement of the tentative budget and budget 13 message shall appear not less than 105 days prior to the beginning of the ensuing fiscal year.

15 Sec. 5-5 Consideration by the Board.

After the conclusion of the public hearing the Board of Directors shall continue its consideration 16 17 of the tentative budget. 33 Sec. 5-7 Certification.

A copy of the budget as finally adopted shall be certified by the [General] TOWN Manager and recorded in a book kept for that purpose in the office of the Town Clerk. From the date of the beginning of the fiscal year the several amounts stated in the budget as proposed expenditures shall be and become appropriated to the several objects and purposes therein named.

39 Sec. 5-11(a) Appropriation of gifts or other aid.

Any gift, contribution, income from trust funds, or other aid or income from any private source or from the federal or state governments, which is carried upon the records of the Town or is received after July 1, 1968, shall be entered upon the records of the General Fund in a manner recommended by the [General] TOWN Manager and approved by the Board of Directors. 1 Sec. 5-13 Director of Finance to assume former powers and duties of Town Treasurer.

The Director of Finance shall have all the powers and perform all the duties which are vested by 2 statute in town treasurers, and, except as otherwise provided in this Charter, as amended, all the 3 4 powers and duties which were formerly vested in the Town Treasurer by this Charter. He shall have custody of and disburse all funds belonging to the Town and shall deposit the same in such 5 banks and trust companies as may be designated by the Board of Directors on the recommendation 6 of the [General] TOWN Manager. He shall keep such books and records as the Board of Directors 7 shall prescribe. He shall be the Treasurer of the Town Deposit Fund and shall have authority to 8 invest and reinvest the same in securities legal for investment of trust funds under the General 9 Statutes. Nothing herein shall be construed to prevent sinking funds and trust funds from 10 11 continuing to be managed by any trust company managing them at the effective date of this Charter unless the appointment is revoked by the Board of Directors. Whenever a vacancy occurs, or any 12 trust fund is hereafter created, the Board of Directors shall have power on the recommendation of 13 the [General] TOWN Manager to designate a trust company or trust companies to manage the 14 same, which designation shall continue until revoked. The Director of Finance or Acting Director 15 of Finance and the [General] TOWN Manager or Acting [General] TOWN Manager jointly shall 16 17 have the power to endorse, negotiate, sign and transfer, on behalf of the Town, any securities in

1 The [General] TOWN Manager shall appoint an Assessor who shall, except as otherwise provided

2 in this Charter, have such powers and duties as are conferred or imposed on assessors of Towns

5 Sec. 6-1 Collector of Revenue.

6 The Collector of Revenue shall be appointed by the [General] TOWN Manager and shall receive
7 and collect all taxes and assessments payable to the Town and such other fees and charges as may
8 be assigned to him for collection by the Board of Directors on the recommendation of the [General]
9 TOWN Manager. Except as otherwise provided in this Charter, he shall have such powers and
10 duties as are conferred or imposed on tax collectors of towns by the General Statutes. In addition

The [General] TOWN Manager shall appoint a Chief of Police who at the time of his appointment 15 need not be a resident of the Town or state but within one (1) year of appointment shall reside 16 17 within the Town. The Chief of Police shall be the executive head of the Police Department and, as such, shall have charge and control, under the direction of the [General] TOWN Manager, of the 18 administration and discipline of the Police Department and of its buildings, property, apparatus 19 20 and equipment. 33 Sec. 10-2 Qualifications of policemen.

No person shall be appointed to the police force nor as a supernumerary or special policeman unless he is of good moral character and habits and in good health and until he shall have passed such examination respecting his educational, physical and general qualifications as may be prescribed by the Chief of Police with the approval of the [General] TOWN Manager.

3 STANDARDS OF OFFICIAL CONDUCT

5 Sec. 2-4 Definitions; Ethics Commission; standards of official conduct. [1]

6 (a) Definitions.

7 1. "Business" means any corporation, partnership, sole proprietorship, firm, enterprise,
8 franchise, association, organization, self-employed individual, holding company, joint stock
9 company, receivership, trust, investment property or any legal entity through which business is
10 conduct for profit.

11 2. "Commission" means the Town Ethics Commission.

3. "Complaint" means a written statement alleging any person subject to the standards of
official conduct has by act or omission violated said standards. Said complaint shall state the acts
or omissions constituting the alleged violations and the approximate date or dates upon which the
alleged violations occurred. The Commission may require the complaint to be under oath.

4. "Gift" means a payment, loan, subscription, advance, deposit of money, services, oranything of value, unless consideration of equal or greater value is received.

18 5. "Family" means a collective body of two (2) of more persons living in one (1) household.

19 6. "Income" means any money or thing of value received, or expressly or impliedly promised,
20 whether in the form of a fee, salary, expense, allowance, forbearance, forgiveness, interest,
21 dividend, royalty, rent, capital gain or any other form of recompense or any combination thereof.

7. "Ministerial action" means an action that a person performs in a given state of facts in a
prescribed manner in obedience to the mandate of legal authority, without regard to, or the exercise
of, the person's own judgment upon the propriety of the action being taken.

8. "Person" means an individual, business, corporation, union, association, firm, partnership,
committee, club or other organization or group of persons.

9. "Probable cause" means a finding that reasonable grounds exist to believe that a violationof the Standards of Official Conduct has occurred.

10. "Town agency" means any department, commission, board, bureau, committee, legislative
body, agency, or other establishment of the executive or legislative branch of the Town, including
the Board of Education to the extent that the provisions of this section may lawfully apply to the
Board of Education.

11. "Town employee" means any individual who receives income, weekly or otherwise, from the Town or who is responsible for taking or recommending official action of a nonministerial nature with regard to: (i) contracting or procurements; (ii) administering or monitoring grants or subsidies; (iii) planning or zoning; (iv) inspecting; licensing or regulating any person; or (v) any other activity where the official action has an economic impact of greater than a de minimis nature on the interests of any person.

39 12. "Town official" means an elected or appointed official in the executive or legislative branch
40 of the Town, excluding members of purely advisory boards and other boards that have no authority
41 to extend public funds or to otherwise exercise the power of the Town.

42

43 (b) Town Ethics Commission.

Creation. There is created an Ethics Commission consisting of seven (7) members who
shall be electors of the Town of Manchester. Appointments to the Commission shall be made by
the Board of Directors. No more than three (3) of the members of the Commission shall maintain

the same voter affiliation. Any vacancy occurring on the Commission shall be filled by the Board

of Directors within sixty (60) days by an elector maintaining the same voter affiliation as originally
held by the vacating member.

Alternate members. The Board of Directors shall appoint alternate members to the
Commission. Such alternate members shall be electors of the Town of Manchester. There shall be
one (1) alternate for each voter affiliation represented on the Commission. An alternate member
shall, when seated, have all the powers and duties as set forth herein for members. An alternate
shall only be seated in the place of an absent member maintaining the same voter affiliation.

9 3. Terms. Members and alternates of the Commission shall serve for a three-year staggered
10 term, each to commence on the Tuesday after the third Monday in November.

4. Officers. The Commission shall elect a Chairman, Vice Chairman and Secretary. In the
absence of the Chairman or in the event of a vacancy in that position, the Vice Chairman shall
serve as Chairman.

14 5. Quorum. Any action by the Commission shall require the affirmative vote of a simple15 majority of its members, and a simple majority shall constitute a quorum.

6. Meeting. The Chairman or any three (3) members of the Commission may call a meeting,
provided that at least three (3) days' advance notice of the meeting is given to all members.

18 7. Compensation. Members of the Commission shall not be compensated, but shall receive19 reimbursement for their actual and necessary expenses.

20

21 (c) Powers of Commission.

Rules and regulations. The Commission shall prescribe and publish, after notice and opportunity for public comment, rules and regulations to carry out the provisions of this Act.

24 2. Reports. The Commission shall prepare and publish such reports as it may deem25 appropriate.

Advisory. The Commission, on its own initiative or upon request, may issue and publish
advisory opinions on the requirements of this Act for those who wish to use the opinion to guide
thir own conduct.

4. Complaints. The Commission, through its special counsel, shall conduct an investigation
upon receipt of a written complaint by any elector or taxpayer of the Town of Manchester alleging,
under oath or affirmation, a violation of the standards of official conduct.

5. Annual report. The Commission shall prepare an annual report for submission to the Boardof Directors.

34

35 (d) Investigations and hearings by Commission.

Special counsel. The Commission shall appoint an attorney to act as special counsel to the
 Commission, which appointment shall continue at the pleasure of the Commission. The special
 counsel shall not be a member of the Town Attorney's staff. The special counsel shall be
 compensated for his or her services on a case-by-case basis at public expense.

Authority. The Commission shall refer any written complaint received by it to the special
counsel for investigation. The Commission shall, not later than five (5) days after the receipt of
such complaint, notify by registered or certified mail any person against whom such complaint
was filed. A copy of such complaint shall accompany such notice.

A 3. Powers of special counsel. The special counsel shall conduct an investigation of each
complaint to determine if probable cause exists and shall make recommendations to the
Commission based upon the investigation. Special counsel shall recommend dismissal of the

complaint in the event probable cause is not found. In the event the special counsel finds probable 1 cause, he shall set forth the particular section or sections of the Standards of Official Conduct 2 which he finds to have been violated and may (1) recommend the complaint be accepted as filed; 3 4 (2) recommend amendments to the complaint; or (3) recommend additional charges be added to the complaint. The special counsel shall make recommendations to the Commission within the 5 time limits set by the Commission but in no event more than ninety (90) days after receipt of the 6 complaint. In unusual circumstances the Commission may grant an extension to special counsel, 7 not to exceed an additional sixty (60) days. 8

9 4. Review by Commission. The Commission shall, within sixty (60) days of receipt of special
10 counsel's recommendations, meet privately to review each recommendation. The Commission
11 shall dismiss the complaint or set a date for a public hearing thereon or on the amended complaint,
12 which hearing shall be held no later than sixty (60) days thereafter. The Commission shall give
13 public notice of the date fixed for said hearing at least fourteen (14) days prior thereto. Notice of
14 the Commission's decision to either dismiss the complaint or hold a public hearing on the
15 complaint shall be given to the complainant and to the person subject to the investigation.

5. Confidentiality. Irrespective of any statute to the contrary, the complaint, the probable
cause investigation, the recommendations of special counsel and the minutes of the meeting of the
Commission to receive special counsel's recommendations shall not be disclosed to the public
unless and until the Commission sets a date for a public hearing on the complaint.

6. Witnesses to testify. Any person may be compelled, by subpoena signed by competent
authority, to appear before the Commission to testify in relation to any complaint brought to the
Commission, and may be compelled, by subpoena signed by competent authority, to provide
before the Commission for examination any books or papers which in the judgment of the
Commission are relevant to the inquiry or investigation.

7. Hearing procedure. Such hearing shall be open to the public and shall be conducted in
accordance with the Commission's rules and regulations. Special counsel shall present evidence
against the respondent. The respondent shall be entitled to counsel, to present evidence and to
examine and cross-examine witnesses.

8. Recording of hearing. The public hearings of the Commission shall be recorded at public
expense. A written transcription of the recording shall be available to the public at the requiring
party's expense. A written transcription of the recording shall be available to the Commission, at
its request, at public expense.

9. Memorandum of decision. The Commission shall, within thirty (30) days after conclusion
of the public hearing, file a memorandum of decision containing its conclusions and
recommendations and shall either dismiss the complaint or shall recommend appropriate action to
the Board of Directors.

38 (e) Standards of official conduct.

No person shall offer or give to a Town official or Town employee or a member of his or
 her family and no Town official or Town employee shall solicit any gift to influence the official
 or employee in the performance of his or her official duties.

A2 2. No Town official or Town employee shall accept any benefit or income in addition to that
received in his or her official capacity for having exercised his or her official powers or performed
his or her official duties.

3. No Town official or Town employee shall use or disclose information not available to the 1 general public and gained in the course of, or by reason of, his or her official position or activities 2 to further any person's financial interest. 3

4 4. Any Town official or Town employee who has, or whose family has, a financial interest, distinct from that of the general public, in any decision of any Town agency shall disqualify 5 himself or herself from participating in that decision. Any decision made as a result of a violation 6 of this provision shall be voidable, at the option of the Town. 7

No Town official or Town employee shall knowingly have or acquire any financial interest 8 5. or beneficial interest, direct or indirect, in any business that is incompatible with the proper 9 discharge of his or her official duties or that may tend to impair his or her independence or 10 11 judgment in the performance of his or her official duties.

No Town official or Town employee shall knowingly misuse or misappropriate any Town 12 6. fund or Town asset. 13

5 Sec. 9-3 Superintendent of Schools.

6 The Board of Education shall appoint a Superintendent of Schools. [As to any term of office that

7 commences after January 1, 1997, the Superintendent need not be a resident of the Town or state

8 at the time of appointment but within one (1) year of appointment shall reside within the Town.] 9

10 Sec. 10-1 Chief of Police.

The General Manager shall appoint a Chief of Police [who at the time of his appointment need not 11 be a resident of the Town or state but within one (1) year of appointment shall reside within the 12 Town]. The Chief of Police shall be the executive head of the Police Department and, as such, 13 shall have charge and control, under the direction of the General Manager, of the administration 14 15 and discipline of the Police Department and of its buildings, property, apparatus and equipment. The Chief shall appoint such subordinate officers and members of the personnel in the Police 16 Department, including supernumerary and special police, as he may deem necessary and shall fix 17 their compensation within a scale of wage rates recommended by him and approved by the General 18 Manager and within the appropriations made by the Board of Directors. The Chief shall have 19 control over traffic and traffic regulations and shall be the traffic authority of the Town with all 20 21 the powers and duties within the Town vested in and imposed upon traffic authorities by the General Statutes. He shall make and enforce such reasonable rules, orders and regulations, not 22 inconsistent with the General Statutes and the provisions of this Charter, as may be necessary 23 efficiently to exercise all the powers and duties imposed upon and vested in him and the 24 Department, including the duties and discipline of the personnel of the Department. He shall have 25 authority to administer oaths and take evidence in all proceedings relating to the direction and 26 control of the Police Department. 27

29 Sec. 10-12 Town Fire Department.

The General Manager shall appoint a Fire Chief [who at the time of his appointment need not be 30 a resident of the Town or state, within one (1) year of appointment shall reside within the Town]. 31 He shall be the executive head of the Fire Department and as such shall have charge and control, 32 under the direction of the General Manager, of the administration and discipline of the Fire 33 34 Department and of its buildings, property, apparatus and equipment. The Chief of the Fire Department shall appoint such subordinate officers and members of the personnel of the Fire 35 36 Department as he may deem necessary and shall fix their compensation within a scale of wage 37 rates recommended by him and approved by the General Manager and within the appropriations 38 made by the Board of Directors. The Chief of the Fire Department shall make and enforce such reasonable rules, orders and regulations, not inconsistent with the General Statutes and the 39 40 provisions of this Charter, as may be necessary efficiently to exercise all the powers and duties imposed upon and vested in him and the Department, including the duties and discipline of the 41 personnel of the Department. Nothing herein shall be construed to prevent the continuance of 42 volunteer fire companies, together with such paid assistants as may be deemed advisable. 43

45 Sec. 11-3 Director of Public Works; powers and duties.

The General Manager may appoint and may remove a Director of Public Works [who at the time 1 of his appointment need not be a resident of the Town or state but within one (1) year of 2 appointment shall reside within the Town]. The Director of Public Works shall be experienced in 3 4 the management of municipal public works projects and shall be responsible for the efficiency, discipline and good conduct of the Department and in accordance with such personnel rules and 5 regulations as may be adopted by the Board of Directors or included in this Charter, shall appoint 6 and may remove such deputies, assistants and employees as he may deem necessary within budget 7 appropriations and shall prescribe their duties. He shall exercise his powers and discharge his 8 duties under the general supervision of the General Manager. He shall organize the work of the 9 Department and establish such divisions within the Department in such manner as he shall deem 10 most economical and efficient, provided the Director of Public Works may, at his discretion, serve 11 as head of any such divisions. The Director of Public Works shall make recommendations as to 12 the acceptance of streets sought to be dedicated to public use. He shall supervise the granting of 13 all permits to excavate or disturb any highway or other public property or to make any special use 14 thereof and shall exercise such supervision and control over all public utilities in the Town as is 15 accorded by law to the Town. 16

The Director of Public Works may select and employ engineering and architectural or other 18 qualified firms or individuals to assist in the preparation of surveys, designs, plans and 19 20 specifications when in his judgment such assistance is necessary, in accordance with § 5-17 of this

Sec. 12-4 Superintendent of Water and Sewer Department. 23

The General Manager shall appoint a Superintendent of the Water and Sewer Department [who at 24 the time of his appointment need not be a resident of the Town or state, but during the tenure of 25 office shall reside within the Town]. The Superintendent of the Water and Sewer Department shall 26 be the executive head of the Department and, as such, shall have charge and control, under the 27 direction of the General Manager, of the administration and discipline of the Department and of 28 the buildings, machinery, equipment and property of all kinds used by the Department. The 29 Superintendent shall appoint, with the approval of the General Manager and within the limits of 30 the appropriations made by the Board of Directors, such employees of the Department as he may 31 deem necessary for its proper management and operation, and shall fix their compensation within 32 33 a scale of wage rates recommended by the General Manager and approved by the Board of 34 Directors.

6 Sec. 2-2 Officers appointed by the Board of Directors.

(a) There shall be appointed by the Board of Directors for the Town a General Manager, a Planning 8 9 and Zoning Commission consisting of five (5) members, a Zoning Board of Appeals consisting of five (5) members, and alternates as provided by statute, a Library Board consisting of eleven (11) 10 members, a Board of Tax Review consisting of three (3) members, a Town Attorney, an Advisory 11 Recreation and Park Commission consisting of five (5) members, an auditor or auditors, and an 12 Advisory Board of Health. The Town may by ordinance or resolution approved by the Board of 13 Directors provide for other offices, departments, boards and commissions and the duties and terms 14 15 thereof and methods of appointment thereto. All of the officers appointed by the Board of Directors under the provisions of this section, except the General Manager and auditor or auditors, shall be 16 electors of the Town at the time of their appointment, and, with said exceptions, all appointees 17 except as hereinafter provided, regardless of the date of the original appointment, shall hold office 18 until the Tuesday after the third Monday in November in the year in which their term expires and 19 until their successors shall have been appointed and qualified. If any officer appointed by the Board 20 21 of Directors under this section, who is required to be an elector of the Town, shall cease to be an 22 elector during his term of office, then his office shall automatically become vacant and the Board of Directors shall appoint a successor. 23 24
