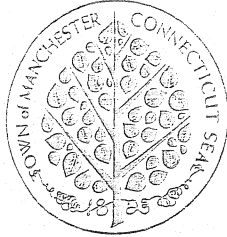

Dear Secretary Bysiewicz:

Pursuant to the requirements of §9-371 of the Connecticut General Statutes, I hereby submit the "Report of Referendum" pertaining to amendments to the Manchester Town Charter, submitted to the voters on November 4, 2008.

**Question No. 1:** Shall the Town of Manchester amend section 3-4 of the Town Charter to provide that the top vote-getter be elected Chairman of the Board of Directors?

**Yes - 15,816 No - 6,671**

**Question No. 2:** Shall the Town of Manchester amend section 2-4 of the Town Charter to remove the Standards of Official Conduct from the Charter and enable a supermajority of the Board of Directors to adopt Standards of Official Conduct by ordinance, and thereafter amend them as may be required?

**Yes - 10,149 No - 11,117**

**Question No. 3:** Shall the Town of Manchester amend chapter 5 of the Town Charter to provide for a petition for budget referendum? **Yes - 15,443 No - 6,301**

**Question No. 4:** Shall the Town of Manchester amend sections 5-13 and 5-14 of the Town Charter to eliminate the positions of Town Treasurer and Assistant Town Treasurer? **Yes - 12,122 No - 9,899**

**Question No. 5:** Shall the Town of Manchester amend section 3-3 of the Town Charter to increase compensation of the members of the Board of Directors to \$4,500 annually for the Chairman, \$3,500 annually for the Deputy Chairman and Secretary, and \$3,000 annually for the other board members?

**Yes - 8,953 No - 13,357**

**Question No. 6:** Shall the Town of Manchester amend the Town Charter to make certain technical and administrative changes? **Yes - 14,635 No - 7,070**
