Town of Manchester, CT Substantial Amendment to Consolidated Plan and Annual Action Plan

The CARES Act requires the Town to undertake a second substantial amendment to its Consolidated Plan (2020-2024) and the Annual Action Plan for the program year 10/1/2020-9/30/2021 to allocate two rounds of CDBG -CV funding designated to address the community needs resulting from the COVID-19 pandemic. CHANGE #1: ACCEPT CDBG-CV FUNDS:

The Town has received notice of two rounds of CDBG-CV funds totaling \$812,580.00

CHANGE #2: CDBG-CV FUNDING TO HUMAN SERVICES:

The Town is proposing to allocate funds in the amount of \$660,184.00 to provide COVID-19 related human services. Final awards subject to negotiation of regulatory compliant scope and budget. Programs include:

Programs to address Health and Wellness needs:

- Manchester Department of Leisure, Family, and Recreation: Recreation on the Run
- Manchester Health Department and Fire-Rescue- EMS: Mobile Health Program
- Manchester Early Learning Center: Early Education Support
- Community Renewal Team: Senior Engagement

Programs to address Food Insecurity:

- Manchester Human Service Department- Senior, Adult, and Family Division: Senior Meal Program
- Second Congregational Church: Food Pantry

Programs to address Housing Instability:

- Manchester Human Service Department- Senior, Adult, and Family Division: Housing Stabilization Assistance
- Interval House- Domestic Violence Survivor Assistance Program

CHANGE #3: CDBG-CV FUNDING TO PARK IMPROVEMENTS

The Town is proposing to allocate funds in the amount of \$26,000 to Manchester Department of Leisure, Family, and Recreation for the North West Park Screen Project

CHANGE #4: FUNDING TO PLANNING AND ADMINISTRATION

The Town proposes to allocate \$126,396.00 for the Planning and Administration of CDBG-CV funds.

These activities are in direct response to the impact of COVID-19 and are consistent with the Town's Five Year Consolidated Plan of providing essential services to low- and moderate-income households.
