Civil Union Conversion to Marriage:

Effective October 1st, 2010 per Connecticut General Statute § 46b-38rr, Civil Unions will convert to marriages by law. This exception is to those that have been dissolved or have dissolution proceedings pending.

As of this date the civil union laws will be repealed so that civil union licenses cannot be issued on or after October 1st, 2010.

There will be two procedures available for the issuance of a converted civil union record:

- ◆ The first procedure will allow for the issuance of the civil union certificate accompanied by a statement that the civil union has been converted to a marriage certificate.
- ♦ The second procedure provides for the conversion of the civil union certificate to a marriage certificate. This second option is only executed when one of the parties to the civil union requests that the civil union be converted to a marriage. The request form must be submitted to the town in which the civil union was performed. This form allows for the civil union information to be recreated onto a marriage license that will now be issued in its place.
- For persons requesting the document conversion in person, they must submit a 'Request for Conversion' application form. They will also be able to sign the bottom of the new certificate.
- For persons that are making a request by mail, they can use a 'Request for Conversion' application form that will contain the affirmation statement. In this case, the new license will state 'signature on file'.
