WHERE DOES MY WATER COME FROM?

The purple zone receives nearly all their water directly from the Globe Hollow Treatment Plant. The blue zone is a blended combination of water from the Charter Oak and Parker Street municipal wells and the Globe Hollow Treatment Plant. The orange zone is a blend of water from the Charter Oak Wells, Progress Drive, and the Globe Hollow Treatment Plant. The yellow zone is a blend of well water from the New State Road and Love Lane Wells.

Concentrations reported in the Water Quality Report are based on weighted flow averages. Values above represent the raw values from testing. The water you receive is blended from multiple water sources. While the colored columns correspond roughly to the map please refer to the above paragraph to factor in each source that contributes to your geographic zone.
